## **Consignment terms and conditions:**

- 1. Velocity Cycle and Ski (VCS) provides a safety check and assessment of all bikes/items. VCS reserves the right to refuse any bike/item.
- 2. We offer consignors a 25% discount on all parts required to get the bike in working and salable condition.
- 3. VCS will retain the bike/item for a selling period of thirty days. This period will commence at the completion of any repairs required.
- 4. Bike/item must remain in the custody of VCS for the full 30-day selling period or until it has been sold. If the consignor removes the bike/item before the end of the 30-day selling period, a fee equaling 20% of the selling price will apply. Initial \_\_\_\_\_\_
- If the bike/item has not sold after the 30-day selling period has elapsed, VCS will contact the
  consignor to re-evaluate the selling price and adjust accordingly. This selling period can be
  extended in thirty-day increments.
- 6. When the bike/item has sold, the consignor will receive:
  - 75% cash or 80% in-store credit on selling prices of \$750 or less.
  - 80% cash or 85% in-store credit on selling prices of \$751 to \$1500.
  - 85% cash or 90% in-store credit on selling prices of \$1501 or greater.

Note: GST will be applied on all sales.

- 7. In-store credit to be applied to new, regularly-priced items. If a bike/item is not in our stock and needs to be ordered, shipping charges may apply depending on the item(s).
- 8. If the consignor chooses cash payment, payment will be in the form of a VCS company cheque and will be issued within 7 business days.
- 9. Unsold bike/item must be picked up within 10 days or a storage fee of \$5.00 per week will apply. Initial \_\_\_\_\_
